C24-02: PS- to date has not renewed his PS license. COA is unable to provide surveying in W.V. with non-licensed PS as SIC, no response to complaints, Consent Agreement or any other correspondence.

C24-03: Board voted to offer Consent Agreement.

C24-05: Terms of Consent Agreement met. Dismissed.

C24-06: Tabled for investigator to review new information submitted by complainants attorney.

C24-07: Consent Agreement has been signed and returned to the Board Office. Terms still need to be fulfilled.

C24-09: Attorney and complainant have expressed desire to appeal and given deadline of 2/28/25 to submit to ICA.

C25-01: PS must upgrade survey to meet Minimum Standards. Board voted to offer Consent Agreement.

C25-03: Dismissed, terms of previous complaint fulfilled.

C25-04: Dismissed, recording of map not required by law or in the work order.
